Update on Threat Facing GOCO

As anticipated, Representative Jerry Sonnenberg (R-Sterling) introduced today a measure that would ask voters to amend Article XXVII of the Constitution (the GOCO Amendment) to allow the State to declare a Fiscal Emergency and transfer lottery proceeds to the state education fund. The legislation, House Concurrent Resolution 10-1007 (HCR10-1007), has been assigned to two House committees: Education and State, Veterans, and Military Affairs.
